<b>QUESTION #1</b>							
<b>Shall an act passed by the general court entitled, An Act prohibiting certain multiple office holdings in the town of Burlington be accepted?</b>							
Summary: This question is being presented to the voters pursuant to the provisions of Chapter 216 of the Acts of 2007, a special act applicable to the Town of Burlington. The request for the special act was approved by the May, 2006 Annual Town Meeting. The special act, if accepted by the voters, would prohibit elected officials in the Town of Burlington from simultaneously holding more than one elected office. No such restriction is found in the Massachusetts General Laws. Elected officials holding office as of the date of acceptance of the special act would be exempt from the prohibition contained therein until the expiration of their current term of office.							
<b>A YES VOTE</b> would accept the special act and prohibit elected officials in the Town from holding additional elected offices.							
<b>A NO VOTE</b> would reject acceptance of the special act, thereby maintaining the status quo, and continue to allow elected officials in the Town to simultaneously hold more than one elected office.
