MINUTES

Executive Session called to order by Chairman Fusco at 7:12 p.m. with Superintendent-Director McIntosh and the following members present: Ms. Asbedian, Ms. Bartolone, Mrs. Gillis, Ms. Kim, Ms. Lawson and Messrs. Fiore, Moffatt and O'Donnell. Mrs. Meuse was absent.

Mr. Fusco began the meeting by thanking Ms. Bartolone, Mrs. Meuse and Messrs. Fiore and O'Donnell for working with the Superintendent and legal counsel to negotiate new union contracts for the Paraprofessionals and Educational Technology/Maintenance. Mr. Bagni, as President of the Shawsheen Teachers' Association, met with Units B and C earlier this afternoon and both groups voted unanimously to ratify the contracts.

Superintendent McIntosh explained that these contracts were written to closely follow the Teacher's contract, and somewhat more loosely the Clerical contract for the full-year employees.
