6. A ZBC Style Guide Review -to align with current ZBL

- We've changed the MGL references in the Zoning Bylaws. We should change our style guide to conform to the use now codified in the Bylaws.
- Should also regularly coordinate with the General Bylaw Review Committee on style and use of definitions. In particular, the definition(s) of "Impervious Surface" were discussed. These differ in the General and Zoning Bylaws. Should be congruent with the Wetland Protection Act and other relevant legislation.

7. ZBRC Future Amendment process / documentation discussion

- S. Ellis presented a spreadsheet table of potential initiatives as suggested at past
 meetings. Priorities were discussed. K. Kassner briefed us on how a priority list
 functions in the Planning Department.
- (K Kassner departs at 7:31pm)
- E. Covino briefed us on the Planning Board priority list. Suggestion is to document priority (importance to town, i.e. value of effort), and the amount of effort likely required to make a substantive change. That way priorities can be set by return on invested effort.
- E.g. signage
- Need to better document the definition and scope of issues that have been suggested (synopsis for each item).

- Shari will approach Economic Development Director (EDD) to see about a briefing on any issues where zoning input might be helpful
- A. Ungerson explained that a COVID task force meets regularly, EDD, Board of Health, Planning, Build Dept. Melisa Tintocalis (EDD) has a good sense of all the moving parts. There are a number of emergency orders and approvals that would cease as the overall state of emergency is lifted.
